RULES AND REGULATIONS

PURPOSE OF MONUMENT RULES & REGULATIONS

First and foremost, it must be remembered that Catholic Cemeteries are consecrated by the Roman Catholic Church and are therefore religious in nature. By their existence, Catholic Cemeteries make a faith statement. Any memorial of any type placed within Catholic cemeteries will be evaluated in this context.

The Cemetery Board reserves the right to specify the terms of purchase of all burial rights in graves or lots and to fix the number of interments allocated to a grave or lot. They also reserve the right to set minimum and maximum lot sizes in designated areas.

1. Right of Burial Easement

- a. Contact Administrative Assistant for package of forms.
- b. Cemetery Easement Titles for cemetery lots may be purchased at the Parish Office.
- c. Purchase must be paid in full within 30 days after selection of grave sites. The Cemetery Easement with parish seal may not be granted until payment is made in full. After 30 days have elapsed lot selections will not be held.
 - i. Cemetery Lot rates: (1) \$625.00 for current, active parishioners of 5+ years; (2) \$825.00 for former, inactive parish members, also includes parishioners less than 5 years; and (3) \$1,025.00 for non-parish members who: (a) have family buried in the cemetery, (b) were baptized at the parish, and/or (c) have family who are current, active parishioners (category 1) who will also be buried in our cemetery (have purchased lots). Purchases in this category must be approved by the pastor.
 - ii. Purchaser of lots must agree to share monument with opposite lot owner. If opposite party uses monument they must agree to pay one-half of un-engraved cost of monument.
 - iii. \$100.00 is due at time of burial to the Cemetery Fund.
 - iv. \$100.00 is due at time of burial for the Church Stipend
 - v. See "Funeral Fees" for other fees that may be applicable.
 - vi. No interment of two or more bodies shall be made in one grave except in the case of a relative and infant.


vii. Cremation - Cost to bury on an existing full grave is $\frac{1}{2}$ of the current rates to buy an existing lot. Maximum of 3.

2. Monument

- a. Headstones the most suitable ornament is the cross, which accordingly, should be found on every memorial. Epitaphs and symbols on memorials should be in the spirit of the Catholic Church.
 - i. Double & Single Stone Prints Available
 - ii. Maximum Dimensions'- 25" height 24" width per site, up to 48" for shared site. Base included with HS purchase
 - iii. Footing maximum 30" width minimum of 3-4-inch border around base. (Foundation supplied by manufacturer, typically flush to ground)
 - iv. Must be installed per rules approved by Cemetery Sexton.
 - v. Granite stone recommended. Other materials, and styles, must receive prior approval.

- b. Head/Foot Stone placement permits; contact Cemetery Sexton to secure permit required for installation of all monuments and foot stones.
- c. Purchaser of lots must agree to share monument with opposite lot owner if engraved. If opposite party uses monument they must agree to pay $\frac{1}{2}$ of un-engraved cost of monument.
- d. Headstones the most suitable ornament is the cross, which accordingly, should be found on every memorial. Epitaphs and symbols on memorials should be in the spirit of the Catholic Church.

- ii. Maximum Dimensions'- 25" height 24" width per site, up to 48" for shared site. Base included with HS purchase
- iii. Footing maximum 30" width minimum of 3-4-inch border around base. (Foundation supplied by manufacturer, typically flush to ground)
- iv. Must be installed per rules approved by Cemetery Sexton.
- v. Granite stone recommended. Other materials, and styles, must receive prior approval.

e. Foot stones

- i. See Permits-Monument, Foot Stones document
- ii. Must be flat / flush to ground within dimension of gravesite.
- iii. Granite and bronze material allowed.
- iv. Foot stone thickness of 4"-6" inch minimum.

3. Burial Vaults

- a. Caskets must be entombed in burial vault.
- b. Cremation urns must be encased in urn vault.
 - i. Granite / Concrete / Composite preferred. 1/2 wall thickness

4. Flowers

- a. Artificial, cut flowers and plants are permitted if contained in an urn or vase secured to the headstone.
- b. Single post flower stands are acceptable, between head stones.
- c. Flowers for headstone locations only.
 - Between stones, not in front of headstone
 - Not on foot stone location.
 - Must not be in the path of the mowers
- d. Flowers for Memorial Day & Labor Day must be removed within two weeks. Flowers remaining after two weeks will be disposed.
- e. No permission is given to individuals for planting flowers, shrubs, or trees.
- f. No "Shepherd Hooks" are allowed.
- g. Containers removed will be placed on side of cemetery

5. Maintenance

- a. Cemetery maintenance will care for the grass cutting and general preservation of the grounds.
- b. General maintenance does not include repair or replacement of monuments or any other objects placed upon or around the monuments or footstones.
- c. Cemetery does not accept responsibility for replacement of vases that are damaged or stolen.
- d. Snow removal only done at time of funeral.

6. General

a. No driving on lawn - stay on roadway.

The Cemetery Board has approved and reserves the right to change or amend these rules and regulations.
